(2) Visa Application Form: Please complete the Visa Application Form online via link <u>https://www.visaforchina.cn/globle/</u>, then print and sign the Visa Application Form. (applicant needs to create a login account)

(mention Required Details on website- location of applying, Dates of travel, Category of visa for Business purpose is M, also pls note that the Flight details in form are mandatory to be filled)

(3) Photo: 2 actual photos (size 35x45mm in colour with 80% face cover on white background as the rules required above).

(4) Photocopy of previous Chinese visas (if any)

(5) Documents on the commercial activity issued by a trade partner in China, or trade fair invitation relevant entity or

individual. The invitation letter should contain:

Information on the applicant (full name, gender, date of birth, etc.) b. Information on the planned visit (purpose of visit, arrival and departure dates, place(s) to be visited, relations between the applicant and the inviting entity, financial source for expenditures) c. Information on the inviting entity or

• individual (name, contact telephone number, address, official stamp, signature of the legal representative or the inviting individuals).

• Inviter Company registration copy.

• Invite letter as per the Embassy format strictly (Invitation letter format attached for your reference)

- Signatory Name should be written in the Chinese language.
- Signatures should be Cross signature on company seal (and should be in Chinese)
- Photo ID of signatory who signs the invitation letter (with name and signature same as those on Invitation letter)
