## Valid passport

## Signed Visa Form

Visa application form duly filled and signed by pax mentioning his/her direct contact number on it.. Row number 1 should have the SURNAME and row number 2 should have the NAME of the applicant. It is mandatory for the applicants to provide their personal mobile number, Email id and Annual income

## Passport Size Photos

2 Photograph (Fresh ones i.e. NOT used earlier for any visa) (latest one, not used in any previous visa, passport size, matt finish, with white background - see footnote for more specifications) 1 photo to be pasted on the visa application form should be signed cross in such a manner that half of the signatures are on the form and half on the photo.
