Türkiye Visa Checklist for Indian Citizens (Tourist/Business)



### **Personal Documents**

Document	Details		
Valid Passport	<ul> <li>Original passport must be valid for at least 6 months beyond arrival date in Türkiye.</li> <li>Must have 2 full blank pages.</li> <li>If passport is issued outside the New Delhi jurisdiction, local address proof is mandatory (refer to remarks).</li> </ul>		
Old Passports	- Submission of previous passports is mandatory. - In case of loss, an original <b>FIR</b> is required.		
Passport Copy	- Photocopies of first, last, and all visa-stamped pages.		
Visa Application Form	<ul> <li>To be filled manually using black or blue ink, in block letters.</li> <li>One biometric photo to be affixed.</li> <li>Must be signed by the applicant or guardian (in case of minors).</li> </ul>		
Photographs	<ul> <li>- 2 recent biometric photos (taken within last 6 months).</li> <li>- White background, full face visible, no specs.</li> <li>- Size: 2.5 x 2.5 inches.</li> </ul>		
Aadhar Card & PAN Card	- Clear, visible copies of both documents.

Document	Details
Hotel Bookings	- Confirmed hotel booking(s) If booked through an agent/operator, a letter with applicant name, check-in/check-out dates, and agent's seal/signature/designation is needed.
Air Tickets	- Round-trip reservation or booking is acceptable (purchase after visa approval is advised).
Travel Insurance	- Must cover the full duration of stay Can be arranged at the Visa Application Centre.

Bank Statement	<ul> <li>Last 6 months' personal bank statement.</li> <li>Originals or copies attested by the bank.</li> <li>Minimum balance: INR 1 lakh per person.</li> </ul>

Company Cover Letter	- Original on company letterhead, signed and stamped Must include: applicant's designation, salary, purpose and dates of travel, responsibility and expense clause, names of accompanying persons.	
Business Invitation Letter (Türkiye)	- Original invitation letter including: name & passport number of invitee, designation, stay duration, purpose, contact info, Turkish company details (tax number, registration, Trade Gazette copy), and company seal/signature.	
For Fairs/Seminars/Conferences	- Original letter on inviting organization's letterhead with full contact details and invitee's name/passport details.

- · Visa provides the right to stay in Türkiye limited only to the duration of the visa.
- Visa does not provide an absolute right to enter Türkiye.
- Those who do not have a passport or a passport substitute document with a validity of at least 60 days beginning from the visa expiration date will not be allowed to enter Türkiye.
- The duration of stay in Türkiye with the visa cannot exceed ninety days in each and every period of one hundred and eighty days.
- If any suspicion arises that the foreigners arriving at the border gates are among those who shall be refused entry into Türkiye, a comprehensive control process shall be carried out by the law enforcement unit responsible for the entry procedures.
- A person who arrives at the border gates in order to enter the country or to transit through the country, but who is not allowed to do so because he/she does not comply with the requirements by the legislation, shall be considered as an inadmissible passenger.
- A removal decision will be taken for foreigners who do not have the right of stay in our country in order for them to be sent back (*Please pay attention to the rules of stay in our country, so that this decision is not taken against you.*)
- Visa does not provide the right to work. If you want to work in our country, you must apply for a working
  visa from the representations of the Republic of Türkiye in the country you are a citizen of, or legally
  residing in, and this request must be approved by the relevant departments.
- · Tourist visas are valid for touristic visits to our country.
  - The residence permit applications of foreigners who apply for a residence permit for tourism purposes after entering our country with a visa **shall not be accepted** (except for those who provide sufficient and regular income with a travel plan, and who apply for family reunification).
