UK TOURIST VISA CHECKLIST

- **Valid passport** with at least 6-month validity from the date of travel, **having minimum one blank back-to-back page for visa stamp**. (Attach all Previous passports to show previous travel history).
- **1 Form** to be filled online after creating an applicant profile. Please provide details in the Performa given.
- **Covering letter** from applicant mentioning name, designation, passport number, purpose and duration of visit in brief. The letter should be duly signed by the applicant and addressed to The Visa Officer, British High Commission, New Delhi. (Please Note: Covering-Letter on Letterhead if applicant is Self Employed or on plain paper if employed).
- **Travel Itinerary** (ticket).
- **Stay Itinerary** (hotel or address in UK)
- **Invitation letter** from inviter mentioning name, designation, passport number, purpose and duration of visit in brief. The letter should be duly signed by the applicant and addressed to The Visa Officer, British High Commission, New Delhi.
- **Inviter's document:** Passport copy, UK Visa Copy, BRP Card copy.
- **Proof Of Occupation: If Employed:** a) NOC from Employer, b) last 6 months salary slips, c) Office ID Card copy. **If Student:** a) Student ID Card b) NOC from school/ college c) Holiday Calendar of School/ college.
- **Bank statements** last 6 months **with Stamp and Sign** from the bank.
- **Income Tax Returns** for the last 3 years.
- **Other Financial documents:** Bank FDRs, Mutual Funds statement, Liquid Assets statement. (if any)
- **If the inviter sponsoring the trip then following documents required:** Inviter's 6 months' salary slips, b) inviter's last 6 months bank statements, c) inviter's Tax Return Papers.
- **Proof of income** a) Personal ITR for 3 yrs. b) Six months' salary slip c) Foreign Exchange endorsement/Copy of Credit Card.
- (As informed over call sir other then this checklist a covering letter will be required with the whole information mentioning your passport number and details, and soft copies of your passport and reason why we are not migrating the family members as of now)
